PRIVACY POLICY

In the consultation of the present web site some data related to identifiable or identified persons can be used. The processing of these data is executed by: Iveco S.p.A., with its registered office in Turin (Italy), Via Puglia 35, 10156. The processing related to the web services of this web site is executed in the above mentioned office of Iveco S.p.A. and it is executed only by Iveco S.p.A. technicians, or by persons eventually charged to make occasional operation of maintenance.

Navigation data. The information systems and the software procedures provided for the working of the present web site, during their normal management, acquire some personal data whose transmission is implicit in the use of Internet protocols of communication. This information is not gathered up in order to be associated to identified subjects, but the particular nature of this information allows the identification of the users through elaboration or association with other data owned by third parties.
